

Putnam County Board of REALTORS Scholarship Application 2017-2018

It is **IMPORTANT** that you read the scholarship requirements before completing your application. Incomplete applications will not be eligible for consideration.

General Information

I. Eligibility Criteria

- A. Applicant must be a graduating senior of a Putnam County High School.
- B. Applicant must be planning to study in the fields of: finance, accounting, real estate, construction or law.
- C. Applicant must demonstrate good citizenship.
- D. Applicant's grade-point average will be considered.
- E. Applicant must be accepted for enrollment at an accredited college, trade school or other approved institution in the United States. Documented proof from that school showing full-time enrollment is required.

II. Application Procedure

- A. The application must be completed in its entirety, including "Supporting Documents".
INCOMPLETE APPLICATIONS WILL NOT BE CONSIDERED.
- B. All applications must be postmarked no later than February 15 and mailed to:

- C. Applicants should also submit these "Supporting Documents":
 1. Two letters of recommendation from individuals who can verify your integrity, scholarship and need. These may be from former teachers, ministers, community leaders, etc., but may not be relatives.
 2. A copy of your high school transcript including class size and class rank signed by the Guidance Director.
 3. An essay describing your plans after high school. 500 words or less.
 4. A brief statement of financial need.
 5. A summary biography.

III. Award Decisions/Acceptance of Awards

- A. Each applicant will be advised in writing regarding the Committee's decision.
- B. Upon notification of a scholarship award the applicant will be required to provide proof of enrollment.

IV. Additional Information:

- A. Scholarships are awarded for one (1) academic year.
- B. While previous scholarships have been up to \$500.00 per school year, with one-half of the scholarship amount being paid each semester, the amount of the scholarship to be awarded is the decision of the Putnam County Board of REALTORS Scholarship Committee, and is subject to change in the number of scholarships and the amount of the scholarship awards each year.
- C. All guidelines are subject to modification at the discretion of the Putnam County Board of REALTORS Scholarship Committee.
- D. All County scholarships will be of equal value.
